## 2008 – 2009 PLAYER'S AGREEMENT

This agreement is made (Month) \_\_\_\_\_ (Day) \_\_\_\_\_, 2008 between the Parent of \_\_\_\_\_ ("PLAYER") and the Florida Panther Alliance ("CLUB")

Player agrees to play on Club's team for the 2008-2009 travel season (September 1, 2008 through 48 hours past the National Competition). The Player agrees to be actively involved with Club's team and no other USA Hockey registered organization unless specifically approved by the Club. Actively involved is defined as participating in all scheduled practice sessions and games in which Player is called upon to participate. Club reserves the right to cut or suspend Player, at the discretion of Club's Board of Directors, in accordance with the Club's Rules, Regulations and By-Laws.

To remain on the team, Parent and Player must: (1) Commit no act detrimental to the sport of ice hockey; (2) comply with all the provisions stated in this agreement; (3) abide by the Club's Rules, Regulations and By-Laws; (4) conduct themselves on and off the ice according to the highest standards of honesty, morality, fair play and sportsmanship; and (5) refrain from conduct detrimental to the best interest of the Club, the league or U.S.A. hockey generally.

**Parent and Player agree to pay Club's fees as follows: \$500.00 upon signing of agreement, \$750.00 due July 15, 2008, \$750.00 due August 15, 2008, \$750.00 due September 15, 2008, \$750.00 due October 15, 2008. Any remaining balance will be due November 15, 2008. PLAYER WILL NOT BE ABLE TO PRACTICE OR PARTICIPATE IN ANY TEAM ACTIVITIES UNLESS FINANCIAL OBLIGATIONS ARE CURRENT. Total team fees will be finalized when all game schedules have been completed. In addition, Parent and Player agree, as a condition of Player being added to the team, to execute a USA Hockey Program Participation Registration form, a USA Hockey Waiver and Release of Liability form and a Medical Release and Treatment form when requested by the club.**

Parent and Player agree and understand that fee is intended to cover ice and general expenses and that any additional costs for participation in tournaments, transportation, hotel or motel accommodations, food, ect... are the responsibility of the Parent. If for any reason, a Player withdraws from the program, including injury, the Parents remain liable for the Player fee as determined by USA Hockey.

**It is mutually agreed that this Agreement contains the entire agreement between the Parties and there are no oral or written inducements, promises or agreement except as provided herein.**
